FEE SCHEDULE

The City Council of the City of Ponca has determined that the fee structure for services and products provided by the City shall be as follows.

Any person who commences any work before obtaining the necessary permit shall be subject to a penalty equal to 100% of the usual permit fee in addition to the required permit fee.

The payment of the fee for the reconstruction, alteration, removal, or demolition for work done in connection to or concurrently with the work authorized by a permit shall not relieve the applicant or holder of the permit from the payment of other fees that are prescribed by law.

Daily Charge for Impounded Animal Actual Cost from South Sioux City Animal Control (SSCAC)

An additional \$50.00 fee per animal shall be payable to the City in order to reclaim an animal from impoundment.

^{*}The fees for Dog Licenses include the State License fee established in Neb. Rev. Stat 54-603.

^{*}A kennel License is required for any lot or parcel of land or place where more than three dogs or more than three cats over the age of 12 weeks are confined, treated, boarded, housed or cared for, and shall include any lot or parcel of land or place where a person, corporation or other entity engages in, conducts, manages or maintains a veterinary business, regardless of the number of animals treated, kept, confined or boarded.
